- V. The floor was opened for public comments on items listed on the agenda. No public comments were posed.
- VI. Office of Parole Administration Update:
 - Valley Hope Contract Deviation Form: Ms. Julie Micek reported a. on the Valley Hope Contract. She indicated that the contract of \$100,000.00 was a deviation from the standard \$49,900.00. Parole Board Legal Counsel, Nicole Miller, spoke with the Department of Administrative Services which guided APA on how to move forward with a sole source contract with Valley Hope. There is a deviation form attached with the contract outlining why there is no one else that can provide this service in the area and why APA can go with the \$100,000.00 contract. The contract is in effect until June 30, 2018. Legal Counsel and Ms. Micek are working on a proposal for an RFP process and getting clients into the residential treatment programs. Ms. Micek also reported that Valley Hope does not have Spanish speaking classes at this time, but they have indicated that they have procedures to work with clients with this need. Ms. Micek presented the Valley Hope contract to the Board for their approval and signatures.

b. Budget and Percentage Cuts: Ms. Micek presented the December 2017 budget. She reported that APA is not over budget and has not even spent half of the allocated budget at this time. APA is looking at money in other accounts that can be transferred to other high budget areas. She reported that a 2% budget cut for the fiscal year of 2018 – 2019 would be around \$154,000.00 and a 4% budget cut for the fiscal year of 2019 – 2020 would be around \$326,000.00.

- c. Business Manager Job: Ms. Micek reported that the Parole Board HR Sub-Committee is currently reviewing a business manager position and an accounting I position and which position would best serve the current needs of APA. She and the committee are looking at how they can reallocate appropriations for this position.
- d. Medical and Victim Notations at Parole Hearings: Ms. Micek requested the Board to put in their notes if an individual is being paroled for medical reasons, victim / public opposition, reasons why they are being paroled or not being paroled, and what facts that influenced their decision.
- e. Contacting Officers Directly: Ms. Micek requested the Board to contact her with any requests for information or questions. She will work with her staff to obtain the information and she will respond back to the Board with the requested information.
- f. National Parole Resource Center letter: Ms. Micek reported to the Board that she received a bulletin notice from NPRC offering technical assistance to parole boards in the areas of evidence based practices, etc. and are encouraged to apply for the services by written letter signed by all Board Members. Ms. Micek presented a letter to the Board for their approval and their signatures to apply for the services.
