  - Prep House Transitional Living Facility
    DAS has approved the lease with an estimated occupancy at approximately 1/1/23. Currently Parole is looking to hire 24 hour staff for this facility. Clients considered to be assigned to this location would be technical violators, who would be living there with additional criteria that has not yet been completely determined. This location is in Omaha at approximately 29<sup>th</sup> and Izard and would hold approximately 12 15 individuals.
  - b. Streamlined parole initiative

Chair Cotton is reviewing the parole process. Currently 200-300 individuals a month on case reviews. Ms. Cotton believes it is time to look how we could streamline the parole process. Whether that is in regards to reviewing of the case file deciding to see or not see the individual or set a hearing without review. Some would require statute changes. Right now the Board reviews every individual annually. Not necessary to see all annually.
