SPECIAL CONDITIONS OF PAROLE FOR SEX OFFENDERS

The following conditions of Parole are specific to individuals who are subject to the Nebraska Sex Offender Registry. Sex Offender Special Conditions may also be recommended for individuals that have been convicted of a current or prior sex offense but is not on the sex offender registry, or whose parole officer determines the conditions would be appropriate based upon the facts of the offense for which they are convicted. These conditions are in addition to the standard conditions of Parole as outlined by the Certificate of Parole and Nebraska Board of Parole.

- 1. You shall have no contact with your victims, including correspondence, telephone contact, or communication through a third party unless approved in advance by the Nebraska Board of Parole. Parolees shall not enter onto the premises, or travel past the victim's residence, place of employment, or other places frequented by the victim.

- 2. You shall have no unsupervised contact, nor reside with children under the age of 18, including your own children, unless approved in advance by the Nebraska Board of Parole. Unsupervised contact is defined as being left alone with a child under the age of 18 years of age. It is also defined as residing overnight in the same residence as a child under the age of 18 years of age regardless if there are other adults present in the residence overnight. All incidental contact with children must be reported to your parole officer and your treatment provider, if applicable. You shall not hold or exercise any position of authority with the following categories of people: children; elderly; families; the mentally, emotionally, or physically disabled; or the culturally different/disadvantaged, without prior approval of the Nebraska Board of Parole.

- 3. You shall notify your parole officer and your treatment provider of any involvement in an intimate relationship at its beginning, and shall introduce the person to your parole officer to disclose your criminal history of offending. Sex offenders who have perpetrated against children shall not date anyone who has children under the age of 18 unless approved by the Nebraska Board of Parole.

- 4. You shall not loiter near, or have residences adjacent (within 500 feet) to any school, daycare, park, arcade, shopping mall, festival, amusement park, playground or other places used primarily by children unless approved in advance by the Nebraska Board of Parole. Nor shall you be employed or participate in any volunteer work that involves contact with children unless approved in advance by the Nebraska Board of Parole.

- 5. You shall not possess any pornographic, sexually oriented or sexually stimulating materials, including visual, auditory, telephonic, or electronic media, computer programs or services. You shall not patronize any adult-themed venue where sexually oriented material or entertainment is available. You shall not utilize any sex-related telephone numbers. Such use of sexually oriented material may only be used with the permission of the Nebraska Board of Parole for treatment purposes only.

- 6. You shall not use a computer for any purpose which might further sexual activity. Such use includes, but is not limited to, possession or viewing of material that is sexual in nature.
- 7. You shall not produce or publish any internet or world-wide web content, nor participate in any electronic social media, social networking services, or online chat rooms, without prior approval from the Nebraska Board of Parole.
- 8. You shall consent to unannounced examination (search) of any and all computer(s) and /or devices to which you have access. This consent to examine includes access to all data and/or images stored on any storage media (including but not limited to cell phones, iPods, PDA's, removable media, thumb drives, camera cards, game consoles, CDs, DVDs) whether installed within a device or removable and separate from the actual device.
- 9. You will be required to undergo DNA testing and/or register as a sex offender if required by state statute. You shall fully cooperate with all procedures required to undergo polygraph testing in conjunction with your treatment program.
- 10. You shall attend, actively participate in, and be financially responsible for the evaluation and treatment approved by the Board of Parole or Parole Administrator/designee and shall not change treatment providers without prior approval of your parole officer. You shall sign information releases to allow all professionals involved in assessment, treatment and behavioral monitoring of your behavior and parole program to communicate and share documentation with each other.
- 11. You will be placed on Active GPS Electronic Monitoring. You will remain on active GPS monitoring until removal is approved by the Nebraska Board of Parole.
- 12. You will be placed on Continuous Alcohol Monitoring (CAM).
