The parole administrator position is currently open and it was recommended within the Transition Implementation Plan

that was authored by Mr. William Burrell and submitted to the Legislature that, pending appointment of a permanent Parole Administrator or legislative changes as proposed by legal counsel, the Director of Supervision and Services act as the Parole Administrator, which is for now statutorily-mandated position.
